Post 550 January 2025 Minutes

- Meeting called to order by Commander Dan Welch on Monday, Jan. 13.
- Colors presented, prayer offered. The POW/MIA flag was placed on an empty chair. Pledge and Preamble recited.
 - Roll call of officers: Sergeant-at-Arms excused.
- Guest Janet Lorenzo, assistant department service officer, The American Legion Department of Minnesota
- Printed copies of the December minutes distributed. Mead moved, Skundberg seconded, and the minutes were approved.
- Commander Dan Welch introduced two members of Post 550 who have joined the Bloomington Honor Guard. Thank you to Sevieng Suparat and Greg Duffy.
- Second Vice Commander Chris Schmid reminded us that the Memorial Day Parade will be on Saturday, May 24, 2025, and the first planning meeting is scheduled for 5:30 p.m. Jan. 22
- Chaplain Jim Mead prayed for the passing of Post 550 members John Nielsen, U.S. Navy, Korea (John once appeared in Life Magazine for being a member of NORAD) 56-year Member, 54-year member, John "Shorty" McWilliams, U.S. Marine, Korea, and Dave Costello A longtime Member, U.S. Army,
- Finance Officer Blaine Beste provided the financial report. Zesch made a motion to approve, which Johnson seconded. Motion carried.
- Membership Director Paul Hassing reported that we now have 251 members signed up for this year. Our goal is 310, so 222 is 81% of our goal. Paul also suggested we need to search for a new Membership Director. He stated that someone who lives in Bloomington would likely be most effective.
- Gambling Manager Tim Engstrom provided the gambling report for December. The Post 550 Gambling Committee recommended the approval of \$10,400 for the following to be paid in January:
 - -\$1000 Wings of the North
 - -\$500 Veterans Campground on Big Marine Lake
 - -\$1,000 Bloomington Speech
- -\$1,000 Bloomington Friends of Forensic (speech), pending a volunteer for Oratorical Scholarship
 - -\$1,500 Every Third Saturday
 - -\$500 Bloomington Mites Hockey
 - -\$500 9th District American Legión Band
 - -\$3,400 Car repair for the spouse of a veteran
 - -\$1000 Savings
- Hassing made a motion to approve the report, and Mead seconded it. Motion carried.
- Gun Safety reports that Saturday, May 3, 2025, is the date of the Spring Class, and Saturday, Aug. 16, 2025, is the date of the fall class.
- The Legion Riders have many runs planned for 2025, including a northern run. Paul Hassing will provide a list for publication on our website and posting in the VFW Post 1296 lobby.
 - Sons of the American Legion: Jim Mead reported 45 members.
- Commander Dan Welch informed everyone of the requirement for a Class C Drivers License with Passenger Endorsement to drive the Legion Bus. He asked if anyone had one or was interested in getting one. The Honor Guard and Baseball will need to come up with volunteers to get the Class C License to drive the bus starting immediately.

(Editor's note: See February and March minutes before acting on this.) Beste motioned to increase this month's savings by an additional \$5,000, and Zesch seconded. The motion carried. Beste also discussed that he will be providing letters to the various committees of the Post asking for goals and funding requests for the coming year.

- Larry Johnson told the story of the "Four Chaplains" who died rescuing civilian and military personnel as the American troop ship SS Dorchester sank in the North Atlantic on Feb. 3, 1943. The chaplains helped the other soldiers board lifeboats and gave up their own life jackets when the supply ran out. The chaplains joined arms, said prayers, and sang hymns as they went down with

- Meeting called to order by 1st Vice Commander Tom Skundberg on Monday, Feb. 10.
- Colors presented, prayer offered. The POW/MIA flag was placed on an empty chair. Pledge and Preamble recited.
 - Ron Iden, a Post 435 member, is considering transferring to Post 550.
 - Roll call of officers: Commander and Second Vice Commander excused. Printed copies of the January minutes were distributed. Beste moved,
- Mead seconded, and the minutes were approved.
- Adjutant Warren Christopherson received letters from Boys State and Legionville. Boys State is requesting High School Students going into 12th grade to attend Boys State this summer at Saint John's University Campus June 8-14. Legionville Summer Safety Camp is open for registration for any child between 9-13 years of age by Sept. 1, 2025. Boys State costs \$350 per student; the registration deadline is April 15. The cost for the Legionville Summer Safety Camp is \$500 per camper. The first session is June 15-20.
- Chaplain Jim Mead prayed for the passing of 24-year Post 550 member James E. Johnson, Coast Guard, WWII.
- Finance Officer Blaine Beste provided the financial report and requested up to \$2,000 for attorney fees for bonding. Mead made a motion to approve the \$2,000, which Crafton seconded, and the motion was carried. Mellin made a motion to approve the financial report, which Johnson seconded. Motion carried.
- Chaplain Jim Mead reported for Membership Director Paul Hassing that we now have 259 members signed up for this year. Our goal is 310, so 259 is 84 percent of our goal.
- · Gambling Manager Tim Engstrom provided the January gambling report and the annual audit's positive results. The cost of the audit is \$6,800

- Chaplain Mead Read letters from Kennedy Softball, Beyond the Yellow Ribbon Committee, and Veterans Campground on Big Marine Lake, thanking us for our donations in December and January.
- Gambling Manager Tim Engstrom notified us of possibly opening another gambling site. He said that TGI Friday's is interested in having American Legion Post 550 add a pulltab booth to their establishment. He will let us know next month regarding the progress.

Tim also provided us with some additional information regarding the bus. With the additional requirements for being a driver, which include a Class C with Passenger Endorsement, it may not be possible to keep. He will provide us with additional information next month, but the bus needs to be parked and not driven for now.

- · Sergeant-at-Arms Mike Mellin requested information regarding Gun Safety classes and Legion Riders dates be added to the website. It was also suggested that the VFW Hall Rental Inquiries should have a note on the website and the Trumpeteer directing those calls to the VFW.
- Finance Manager Blaine Beste mentioned the upcoming District Chili Cookoff and the Bowling tournament. He was inquiring if there was any interest in forming a team for either or both events.
- Larry Johnson informed us that the Story Arts of Minnesota will be at the Bloomington Center for the Arts on April 5 from 10 a.m. to 9 p.m. Larry may be one of the storytellers on that day.

In honor of Black History Month, Larry also recommended a book written by Col. David Rabb of the 785th Medical Company, Combat Stress Control, and the first African American Commander to lead Minnesota Soldiers through wars in Operation Iragi Freedom and Operation Enduring Freedom. The book is called From A to Z What a Veteran Means to Me! A look into the United States Armed Forces' Culture and Veterans Community.
